Ld. counsel for the Respondent No.1 requests for four weeks time to file reply. Let the reply be filed within four weeks with a copy in advance to the counsel for the petitioner. Rejoinder, if any, be filed within two weeks thereafter with a copy in advance to the counsel opposite.

Ld. counsel for the Petitioner has, inter alia, argued that she has acquired 30% share in the Respondent No.1 company ( 10% on 7.11.2014 and 20% on 07.08.2015). However, she has neither been allowed to inspect the statutory records nor is allowed to know the affairs of the company. It has also been stated that assets worth Rs. 1 crore has been created fraudulently for oblique motives.

- (v) Copy of Register of Contracts.
- (vi) A list of all freehold land and buildings held by the company with short description alongwith copies of relevant title deeds, sale/conveyance deeds. Also provide confirmation that the freehold and leasehold properties disclosed above represent all the properties owned and/or occupied by the company.
- (vii) Full Bank Account statements of all Bank accounts, profit and loss statements and all other accounts of the respondent No.1 company from the date of incorporation till date.
