I have heard learned counsel for the parties at length.

During the course of arguments it transpired that the petitioner has written some letters to the Bankers of Respondent No.1-company which has resulted in nonoperation of the bank accounts, renewal of facilities and grant of further facilities. Learned counsel for the Petitioner after receiving instructions states that letters which have been sent and address to the Bankers of respondent No.1 company shall stand withdrawn. Likewise learned counsel for the respondents after obtaining instructions have also stated that status quo in respect of the Board of Directors as on today, fixed assets and shareholding shall be maintained. However, learned counsel further states Respondent No.1-company shall remain entitled to utilize the assets for day-to-day business of the company. If any further encumbrance is to be created on any immovable property the same be done with the prior permission of this Board except the one already created or to be renewed. The monthly statement of accounts shall be filed before the Tribunal in the first week of every month.

These statements are acceptable to each other and shall remain binding.

The Respondent may file their reply within six weeks with a copy in advance to the counsel for the petitioner. Rejoinder, if any be filed within four weeks with a copy in advance to the counsel for the respondent.

Passing of this order shall not be construed as an impediment in any amicable settlement between the parties.
