ORDER

Both the parties are ad idem that there is deadlock between them. It is pertinent to notice that Petitioner No.1 and Respondent No.2 have 50% shareholding each. The functioning of the respondent No.1 company suffers. Therefore both parties have agreed that Hon'ble Mr. Justice A.N. Varma (Retd.) be appointed as an Administrator/Facilitator of the Respondent No.1 company. To facilitate the functioning of learned Administrator/Facilitator the interim order dated 22.12.2015 shall not operate and it stands suspended. There is further agreement that the Administrator/Facilitator shall discharge the following functions:

- (a) To act as Chairman of the Board of Directors.
- (b) To sign the cheques for suppliers, employees and others.
- (c) To certify bills and invoices.
- (d) To appoint an auditor for the company and to get the accounts audited for the year 2014-15.
- (e) To ensure statutory compliances.
- (f) To handle the day-to-day affairs and to take all decisions in the interest of the company on the aid and advice of the Petitioner No.1 and the Respondent No.2.
- (g) The Administrator is to file fortnightly report alongwith accounts before this Court/Forum.
- Respondent No.2 and Petitioner No.1 shall maintain confidentiality of their inter-se communications and would not pass it on to any third-party.
- The communications to the Administrator by either of the party shall be made with a copy to the opposite party.
- Respondent No.1 shall provide the Administrator requisite office space at Regd. Office.

- 5. The parties have further agreed that the Administrator shall consider any objection raised by either party and decide the same keeping in view the interest of Respondent No.1 company.
 - The Administrator shall start functioning from tomorrow, i.e., 12.02.2016 and shall decide his own remuneration after conferring with the parties, if considered necessary.
