


## ORDER

CA No.147, 146 & 145(C-1)/2016:

On 16.03.2016 an order was passed initiating ex-party proceedings *inter alia* against Respondent No.23, 27, 29 & 35. The aforesaid Respondents have filed CA No.147, 146 & 145/2016 respectively for recalling of order dated 16.03.2016 by citing various reasons of non-appearance. The non-applicant-petitioner has filed reply opposing the prayer for setting aside the ex-parte order passed against the applicant-respondent.

2. I have heard the ld. counsel for the parties. I am of the view that there are sufficient reasons given in paras 3, 4 & 5 of the applications for setting aside the ex-parte proceedings. Accordingly, the order dated 16.03.2016 is recalled for reasons stated in the aforesaid paras of the CAs and the respondent No. 23, 27, 29 and 35 are permitted to join the proceedings and they may file their respective affidavits within four weeks with a copy in advance to the counsel for the petitioner.

3. Reply may also be filed by Respondent No.19 alongwith any other respondent. Rejoinder, if any, be filed within four weeks thereafter with a copy in advance to the counsel opposite.
