ORDER

Ld. counsel for the respondents has requested for adjourning the matter for the reason that an order of amalgamation dated 12.02.2016 has been passed by the Central Government. As a consequence thereof Respondent No.29-company is in the process of amalgamation with Respondent No.1 company. Earlier to the order dated 12.02.2016 there was a draft order of amalgamation. However, the aforesaid order has been challenged before Hon'ble Bombay High Court in Writ Petition No.2743/2014 which is still pending. The final order issued on 12.02.2016 has also become a matter of challenge before the Hon'ble Bombay High Court.

In view thereof the pleading may have to be amended. Therefore, hearing is deferred to 04.03.2016 at 2.30 PM.
