## ORDER

No one has put in appearance on behalf of Respondent No.1.

There is serious disputes in the Board of Directors and even a resolution could not be passed by the Board of Directors authorizing any ld. counsel to represent Respondent No.1. Mr. Arun Kathpalia, ld. counsel states that Respondent No.2 & 3 who are in majority have been passing resolutions while managing the affairs of the company. Be that as it may, there is consensus between the Petitioner on the one hand and the Respondent No. 2 & 3 on the other that an Administrator may be appointed. In a connected case namely C.P. No. 124(ND)/2014 this Board has already appointed Hon'ble Mr. Justice R.V. Eswar (Retd.) as Administrator vide this Board order dated 25.02.2016. Accordingly, Hon'ble Mr. Justice R.V. Easwar is appointed as Administrator in this matter as well. Justice Easwar shall be entitled to all the facilities as per order dated 25.02.2016.

The Administrator shall submit his report by the next date of hearing.
