Today, the applicant company has come up with an affidavit stating that the company has paid Rs.72 lakhs out of Rs.1.44 crores to be paid within 30 days from 4.1.2016 and stating that the company would get money in other business transactions on or before 31.3.2016. Hence, extension of time sought as to payment of balance Rs.72 lakhs and also in respect of remaining dues.

2. On seeing the attendance sheet, the order for payment of Rs.2 crores was passed on 15.10.2015 to pay on or before 31.12.2015. Thereafter, when it was not complied with, another extension was given on 4.1.2016 to pay balance Rs.1.44 crores within 30 days from 4.1.2016. The order dated 4.1.2016 is also not fully complied with, If extensions are given like this, it appears that the applicant keeps on asking adjournments saying order is partly complied with, which is not permissible everytime.

3. In view of the same, this Bench hereby seeks explanation as to why this application should not be dismissed on the next date of hearing if the balance payment of Rs.56 lakhs is not being paid by 1.3.2016.
