For the time being, the counsel appearing on behalf of R1, R3 & R4 filed scanned copy of the Vakalatnama disclosing Mr. Anil Sehgal, R3 as authorized signatory on R1 company's behalf, Rajive Jain and Mr. Anil Sehgal in individual capacity are shown as signed on 17.04.2016. R2 is not present.

3. R1 company is directed to file Resolution authorizing Anil Sehgal to appear on behalf of R1 company.
