**ORDER**

Shri Amalesh Bandopadhyay is retiring as Member (Technical) from the Company Law Board, Kolkata Bench on 14.10.2014. Vide Office Order No. PFA/83/2012-CLB dated 13.10.2014, Shri Dhan Raj, Member (Technical) has been transferred from New Delhi Bench of the Company Law Board and posted as Member (Technical) in Kolkata Bench of the CLB with additional charge of Court No.3, New Delhi Bench for any five Continuous working days each month to be opted by him in advance starting from November 2014.
